# REQUEST FOR PROPOSAL FOR EMPANELMENT AS RESOURCE AGENCY (EMI-RA)

#### 1. INTRODUCTION

The Energy Management Centre Kerala invites proposals from Empaneled Energy Auditing firms / Academic Institutions other than schools / R&D Institutions / NGOs from Kerala State to facilitate its Online Certification Program entitled "Energy Efficiency Ambassadors" under the Energy Management Institute of the Energy Management Centre.

#### 2. RESOURCE AGENCY

Resource Agency (RA) is an agency that can work closely with the Energy Management Institute to create content, organize and coordinate online educational courses under the mentorship of EMC. The following agencies can apply for Empanelment as RA.

- i. EMC Empaneled Energy Auditing firms
- ii. Academic Institutions other than schools in Kerala State
- iii. R&D Institutions in Kerala State
- iv. NGOs in Kerala State

#### 3. COURSES OFFERED

In the initial phase, Resource Agency shall conduct two courses as offered by Energy Management Institute. After reviewing the success of these program, EMI & RA will discuss & decide on more course contents on mutual agreement.

- Energy Efficiency Ambassadors- Energy Management & Auditing in Thermal Utilities
- Energy Efficiency Ambassadors- Energy Management & Auditing in Electrical Utilities

#### 4. ELIGIBILITY & APPOINTMENT OF EMI-RAS

Resource Agencies (EMI-RAs) are appointed by Energy Management Institute based on the following criteria.

- Institutional Capacity
- Availability of Infrastructure
- Qualifications of Permanent/Guest Faculty (Minimum Qualification Graduate Engineer) \*
- At least one faculty should be a BEE Certified Energy Auditor (Guest / Permanent)\*
- Previous experience in conducting similar activities
- Past association with EMC

After acceptance of the proposal, a formal agreement will be executed between EMI-RA & Energy Management Centre to conduct Certificate course for Energy Efficiency Ambassadors on Energy Management and Auditing of Energy Management Institute. The agreement shall be made on a Stamp paper of Rs.200/-

#### 5. DUTIES & RESPONSIBILITIES OF EMI-RA

- Schedule the course & Notify with an attractive prospectus as approved by EMC
- Registration of the students
- Conducting the course
- Submitting detailed report to EMC
- Course Duration must be minimum of 15 hours

#### 6. DUTIES & RESPONSIBILITIES OF EMI, EMC

- Creation of Course structure & Syllabus
- Approving the batch and students registered undergoing the courses
- Conducting examination and issuing e-certificates

#### 7. TARGET PARTICIPANTS OF THE COURSE

- Graduates
- Students undergoing post-graduate/under-graduate Degree Programs.

<sup>\*</sup>One Faculty cannot associate with more than one EMI-RA.

#### 8. EMI-RA FEE

• EMI-RA fee is the amount has to be remitted by EMI-RA to EMC, which is Rs. 500/- (+Applicable taxes) per participant.

#### 9. COURSE FEE

Course fee is the fee that can be collected by EMI-RA from participants.
 Maximum course fee is limited to Rs.2000/- (+Applicable taxes) which is inclusive of EMI-RA fee, Examination Fee, Registration fee etc.

### **10. REVIEW OF EMPANELMENT**

 EMC will conduct a review of EMI-RA at the end of each course period and annual renewal of EMI-RA will be on the basis of that review, feedbacks collected from participants and results. EMC has the right to cancel the empanelment of EMI-RA at any point of time with a prior notice of 30 days.
