

Support for Implementing Energy Awareness Program in Residence Associations Guidelines

- I. This scheme is called "Support for Implementing Energy Awareness program in Residence Associations" .
- II. This scheme is applicable for
 - a. Residence associations.
- III. This scheme provides financial assistance to the above-mentioned category of Residence associations for the following activity.
 - 1. Financial assistance for Residence associations :** The following financial assistance shall be applicable for Residence associations.
 - 1.1. Financial assistance for Energy awareness :** The financial assistance shall be Rs.5,000/- (Rupees five thousand) (Excluding taxes) limited to a maximum of Rs.10,000/- (Rupees ten thousand only) (Excluding taxes). Once the programme is completed and verified by EMC, the FA shall be paid directly to the organizer.
- IV. This scheme provides financial assistance for Residence associations who plans to conduct energy awareness programme among its constituents
 - a. The program must be in offline mode and should be conducted in between December 1, 2021 and December 14, 2021.
 - b. The program should strictly follow covid protocols and should be of 2 hours duration.
 - c. The association shall provide shall provide hall and other amenities for the conduction of the programme.
 - d. The resource person shall be provided by the association and should have an energy sector based background.
 - e. The topics to be covered must include energy efficiency, energy conservation and electric vehicles.
 - f. The source material for the programme shall be provided by EMC.
 - g. Maximum financial assistance is limited to Rs.10,000/- (Rupees ten thousand only) (Excluding taxes).
 - h. A minimum financial assistance of Rs.5,000/- (Rupees five thousand) (Excluding taxes) will be provided for the conduction of the programme

with minimum 50 participants and a financial assistance of Rs.10,000/- (Rupees ten thousand only) (Excluding taxes) shall be provided for programs using projector/laptop, with minimum 75 participants.

- i. Banner design shall be provided by EMC.
 - j. To avail of financial assistance, the organizer has to submit the application shown in the Google form provided by EMC.
 - k. Financial support will be limited to the fund availability and weightage of proposals.
- V. To register with this scheme, organizer have to submit a formal application shown in Google forms provided by EMC.
- VI. To avail of the financial assistance, the organizer shall complete all the activities related to the energy awareness programme as prescribed above and submit the application form shown in the Google forms provided by EMC.
- VII. To avail of the financial assistance, the organizer must complete all the related activities in between December 1, 2021 and December 14, 2021.
