While allotting works in connections with carbon credit scheme the junior consultant may not be considered for collecting offers for certain categories/ projects based on qualification standards set by EMC for such projects. The decision in this regard will be entirely at the discretion of Director, EMC • Once the junior consultants meet full criteria, they can be upgraded to senior consultants against request, with a nominal upgradation fee of Rs 10000/-, if they attain the experience within the period of 2 years from the date of empanelment as junior consultant. • The new empanelment period of such upgraded consultants will be for a fresh period of 5 years. • Both Junior and Senior consultants would have an empanelment period of 5 years.
